According to Section 20 of the Act, a DPO must possess:

- Expertise in data protection laws and regulatory compliance.
- > Experience with IT systems and information security infrastructure.
- Risk management and auditing skills.
- High levels of integrity, professional ethics, and confidentiality.
- Effective communication and project management skills, ensuring seamless collaboration with internal and external stakeholders.

DO YOU NEED A DATA PROTECTION OFFICER (DPO)?

Under Section 20 of Jamaica's Data Protection Act, organizations are required to appoint a DPO if they:

- > Are a public authority.
- Process personal data on a large scale, including sensitive data such as genetic, biometric, or health-related information.
- Fall within a class designated by the Information Commissioner.

Even if not legally required, appointing a DPO demonstrates your commitment to privacy best practices and builds trust with customers and stakeholders.
